## MARTIN LUTHER KING, Jr. DAY

## Monday, JANUARY 16th, SSPL

*This year's theme, "Dignity for All," will reflect Dr. King's affirmation of the dignity of all people and all labor. Saratoga LWV will again play a prominent role in the Dr. Martin Luther King, Jr. Day observance.*

This will be the second year that the public celebration will include a volunteer component, as participants spend a morning working at various area non-profit agencies – a part of the National Day of Service. The volunteers will return to the library for a luncheon served by LWV members prior to the public program, which will include reflections on the day's theme, "Dignity for All," by LWV President Patricia Nugent and featured speaker, Jim Kates. Kates is an author and motivational speaker, who as a teenager from Saratoga took part in the Freedom Summer experience in the 1960's, challenging institutional racism in the South. Garland Nelson, of "Soul Session," will blend musical interpretations of the dignity theme into the program.

To him, as to many, it seemed like a step backward, returning to paper and pen. I explained the intent to verify votes if needed. ## Protect Your Right to Vote – January 19<sup>th</sup>

How precious is our right to vote in a democracy! Our organization is founded on the fact that female citizens were once denied the right to vote. Our brave soldiers have fought and died to ensure the right to vote in other countries. Yet as many as five million US citizens have recently lost their right to vote as a result of legislation being passed in more than 20 states, with several more on the verge of passing similar restrictions. In particular, the elderly, minorities, and youth are being disenfranchised. This is the greatest threat to voting rights in our lifetime. And it is a concerted effort to sway election results.

*What's the big deal*, you might ask. So, someone just has to have a photo ID. Well, it IS a big deal. Many of the recently disenfranchised don't have drivers' licenses due to age or poverty. And, yes, some states issue ID's for free. But...first you have to get to Motor Vehicles, and then you have to show a birth certificate to get the ID. Many can't locate their birth certificate or, if born at home, never had one. If your married or adopted name is different than your birth name, you have to show an ID with your original name to request a new birth certificate. (How many of us still have those? You can see how women are particularly impacted.) And on it goes. Plus, there's a fee for applying for a replacement birth certificate, which is a re-introduction of the poll tax, which was outlawed for its discriminatory nature.

This legislation is also very expensive to enact and enforce, at a time when so many municipalities are struggling financially. Yet, statistically, we have a greater chance of being struck by lightning than of being impersonated at the polls.

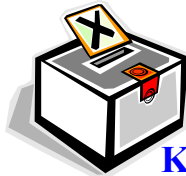
This has the cumulative effect of suppressing the votes of the elderly, minority, and youth populations. If you've seen the elderly women crying on TV because they could not vote this past November – women who have not missed an election in over 60 years – you have a sense of the personal pain involved. Yet, the damage goes much deeper, striking at the very heart of our democracy.

We know you care about this issue – you told us at meetings and through your contributions. On January 19<sup>th</sup> at 7pm at Gannett Auditorium at Skidmore College, we are privileged to be hosting Tim

O'Brien from LWVUS, a specialist on Voter Protection, speaking to us about what is happening and why, and what we can do about it. There will also be panelists from the Albany-based Law and Justice Center, who just returned from the march in DC, and the NYCLU. Under our League's leadership, neighboring Leagues and other organizations will also be joining us as co-sponsors.

**We need all hands on deck for this one – NOTHING this organization does is more important than defending every citizen's right to vote.** Please show up on January 19<sup>th</sup> and bring your neighbors – don't let democracy slip through our fingers.

### Keynote Speaker: TIM O'BRIEN

Tim O'Brien is the Project Manager for the Public Advocacy for Voter Protection (PAVP) project at the League of Women Voters of the U.S. based in Washington DC. He has worked for the League since 2007 – during that time he has expanded the PAVP project's work from 6 to 22 states.

The PAVP project focuses on six major areas identified as essential elements in protecting the votes of all citizens and improving election administration overall:

1. Opposing photo ID and documentary proof-of-citizenship in the voting and registration;
2. Guarding against undue restrictions on voter registration;
3. Improving administration of statewide voter registration database systems and guarding against wrongful or incorrect purging;
4. Improving polling place management;
5. Improving poll worker training and recruitment; and,
6. Fighting against last minute barriers to voting.

Prior to working for the League, Mr. O'Brien was the State Affairs Director for the Human Rights Campaign. He spent five years working in the Wisconsin State Legislature as a policy analyst and owned and operated a small business in Madison, Wisconsin.

## COUNTY OBSERVER CORPS

### Saratoga County Board of Supervisors Meetings, Dec. 1, and Dec. 14, 2011

On December 1, the County held its only public hearing on the county budget. I had been authorized by the League President to speak at the hearing to say that the county should hold more than one public hearing on its budget. I arrived to find a full house. As I signed in to speak at the public hearing I was the 48<sup>th</sup> person requesting to speak! Most of the speakers were protesting the increase in health care costs for county employees and retirees. Employees of Maplewood Manor, supporters of Brookside Museum, and assorted others were also protesting cuts. The interesting speakers to me were those who offered to work with the Board to lobby in Albany for mandate relief and to find savings in county administrative costs. When it was my turn to speak, I pointed out that at least 44 people had already spoken and the county should consider holding another hearing. My remark was applauded by those behind me waiting to speak. Nevertheless, the county board did not hold another hearing and, without publicity, amendments were drafted by the Republican caucus to address the concerns expressed at the hearing.

On December 14, the board held a special session to pass the budget. At the Law and Finance Committee, held just before the board meeting, the change was explained: the county had contracted with a consultant firm to find health care savings. This is based on a change from having Blue Cross Blue Shield manage the claims to a self-insured system.

Once the board meeting opened, the amendments to the budget were outlined. Several of the agencies cut received some restoration of their funds, funding for vacant positions in the county were eliminated, and a raise in property taxes for county residents was proposed. Since this was the first increase in property taxes in 10 years, a number of supervisors spoke against this decision. Concerns were articulated by several supervisors that they had a very short time to study the budget because it was not released until the day after the election. Proposals to begin to look at the county budget and possible savings in the county early in the year were accepted by Board Chairman Wood. *See the report of the Nov. 15th meeting on our website.*

## STUDY OF PRIVATIZATION

The final membership consensus on the LWVUS Privatization Study is on March 27.

The LWVUS Committee Chair, Janis McMillen offers the scope of the study:

*“The purpose of this study is to identify those parameters and policy issues to be considered in connection with proposals to transfer federal, state, or local government services, assets, and/or functions to the private sector. It will review the stated goals and the community impact of such transfers, and identify strategies to ensure transparency, accountability, and preservation of the common good.”*

And, the organization of the study: *“The committee will provide a history and background of privatization, a glossary of terms, legal issues to be considered when privatizing and case studies on successful and unsuccessful privatizing efforts. Finally, the committee will provide suggested policies and parameters to be considered when privatizing.”*

This material will be forthcoming in mid-January, 2012. We are the only League in the Capital District undertaking this expansive study, which can be most intriguing. Some subjects possibly worthy of discussion:

Is there a case for or against privatizing water systems, prisons, covert operations and intelligence gathering, support for our troops, contract negotiations and oversight, or public schools (charters, vouchers, and school services, such as lunch programs), jobs programs, road and bridge construction and repair, public assistance for the needy? *These are just some of the things folks have suggested privatizing.* What criteria should we use to decide?

Should we in Saratoga County consider privatizing Maplewood Manor Nursing Home or the Saratoga County Landfill?

Other Considerations Temporary vs. Long-Term Contracts vs. Full Ownership; Non-Profit Privatization vs. For-Profit Privatization; Laws and Contracts; Quasi-Governmental units like Authorities, Fannie Mae.

## EDUCATION STUDY STATUS

### When will we know the LWVUS position?

Back in the Fall, our league participated in a LWVUS study and consensus regarding the proper role of the Federal Government in Education. Reaching consensus on a national study is a time consuming rather complex experience; we are right in the middle of the procedure.

Our local consensus first had to go to our board for approval, then Francine Rodger and I (the chairs of the study) had to write it up and submit it along with the results from hundreds of other local Leagues. The national committee then has to read and analyze all the reports, write up a proposed position and submit it with a recommendation to the National Board. When that board has decided, we will find out whether we reached a national consensus on which we can act.

As soon as we hear the results, we will post them here in the Bulletin and on our website.

## FIX NEW YORK STATE NOW!



### LWVNY's 2011 Legislative Agenda Steps To a New and Better State Government

**Redistricting:** Create an independent redistricting commission to draft the New York State legislative and Congressional district lines for the 2012 elections.

**Campaign Finance Reform:** Support lower contribution limits, increased disclosure and public financing. In particular, support stronger and effective campaign finance enforcement with increased civil and criminal penalties for violations.

**Ethics Reform:** Put in place a new independent ethics oversight agency and tougher enforcement. Make the legislature more open and accountable through continued rules reform.

**Election Reform:** Improve election processes to extend, encourage and protect voting, including Election Day registration, better ballot design, improved polling place management/poll worker training, and measures to ensure the integrity of all ballots.

**Other League Positions:** The League also has positions on Health Care, the Judiciary, Natural Resources, State Finances, and Social Policy (including Women's Issues) under which we can and do take action.

This was the third year we produced an online voters' guide, and we continue to have increasing results in viewership. There were 952 visits to our guide and that is a great number of folks.

It was also interesting to see how people got to our website. Our own members, of course, know about our website, [www.lwvsaratoga.org](http://www.lwvsaratoga.org), but we had referrals from the Saratogian website, two library websites, Facebook, The Times Union website and the state and national Leagues' websites. While they accessed our site throughout the fall, there was a big jump in visitors on election day (240). People were seeking us out to get information. This is how the social media works, and we need to continue to have a presence out there. It is clear that the referrals are the key to reaching people. We need everyone to think about where we can make a linkage with other internet sites as we continue on into the future.

 The League is known for fair, nonpartisan, informative Candidates Events and we did it again this fall! Approximately 500 audience members

heard from 55 candidates in the five candidate forums:

- Malta**, 40 attendees.
- Charlton**, 80 attendees.
- Clifton Park/Halfmoon**, 140 attendees.
- Saratoga Springs City Council**, 160 attendees.
- Wilton**, 80 attendees.

Audience members had good questions and were eager to participate.

Our online Voters Guide (VOTE 411) included all county supervisor candidates running in contested races plus many of the unopposed candidates and all candidates for Saratoga Springs City Council. We also included the name of the office, candidate names and party lines for the 70 town races in Saratoga County.

Print Version: All of the online guide information was printed in a pull out section of Spotlight News during the first week of October. 20,000 copies were printed with 800 coming to us directly to distribute as we chose. The Saratogian printed some of our online guide information on the Sunday before the election. We distributed our local voters guides in libraries, at Skidmore College, at candidate forums and directly to candidates who wanted them.

**Keynote speaker: James Kates** born in 1945, in White Plains, New York, volunteered for the Mississippi Summer Project after his freshman year at Wesleyan University, and spent that summer helping to implement a special court order encouraging registration in Panola County.

In the fall of 1964, he organized a Friends of SNCC/COFO in Paris, France, to support the work of the American civil rights movement. He returned to Mississippi in 1965, working in Natchez, and later became a public school teacher, a nonviolence trainer for interpersonal and political movements, a poet and a literary translator.

Since 1997, he has co-directed the non-profit literary publishing house Zephyr Press, publishers of *Letters from Mississippi: Reports from Civil Rights Volunteers & Poetry of the 1964 Freedom Summer*.

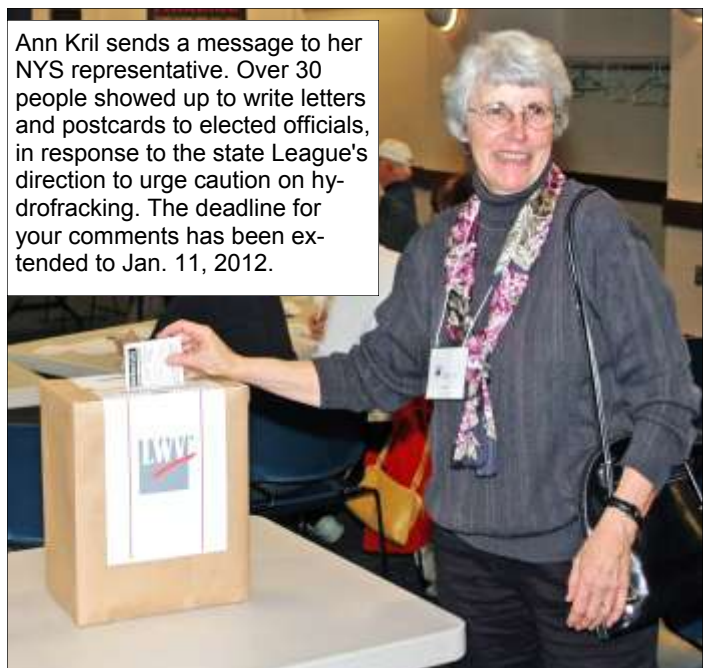
The January meeting will also be used to decide on items to recommend to LWVUS for consideration at the national convention
