## President's Message

### My Study of the Johnson City Dissolution Study

I admit, when I first heard of the Johnson City Dissolution Study, I thought that it would go the way of the previous attempts started by other villages and then dropped by lack of interest or the incentive of significant savings. However, when I heard that this study is leading up to a very possible vote in November, I became very curious about the plan which was developed by the JC Study Team.

In my brief encounter with the study of consolidation of municipalities, I recall some of the strategic points that must be covered in order for a plan to be accepted by the residents and be successful in the long run.

First of all, the committee must set a goal that offers comparable or better services in the community while ultimately producing significant savings for the residents and businesses. The JC Plan specifically states and shows proof of these goals.

There must be a study of all the areas of governing and service and how the changes will affect them. The study team spent 18 months of intensive study within the village, town and county with the people who had the expertise in each area of study.

The fourteen members divided all the departments which needed to be covered and each member concentrated on the one they chose to examine in detail.

The Study must be open to the residents of the village. The study team provided this crucial aspect by holding 30 public meetings involving countless hours of discussion involving committee members from Johnson City, Union, Broome County, Binghamton and various state agencies. In addition their website offers a Feedback link to give the public an opportunity to send in a question or a concern by email. Also a link was provided for anyone to sign up for email alerts.

Funds for this website and other costs were provided by NY State Department of State under the Shared Municipal Services Incentive Grant Program.

Each village or municipality has its own unique issues and challenges and, that is why, where dissolution is the topic, the "devil is in the details." The 90 plus pages of details in the report can make your head spin, but they are there and easy to understand for the resi-

dents to read. If you have any questions about any department from Police, Fire, Sewer, Village Retirees, garbage pick-up or any other, the answers are there.

There will be 32 village positions lost from a total of 126.5 which means a majority of 95 will still have jobs. Businesses all over the nation have realized this sad truth long before this plan was formed and have had to lay off workers. Since there are no Johnson Brothers, Thomas Watson or Ed Link available to change the present situation, government must do its share to alleviate the tax burden on its residents. The tax levy savings for Johnson City are predicted to be \$765,915; for the Town of Union - \$1,086,805. The plan would save an estimated \$4.6 million annually.

Many residents of Johnson City are concerned about loss of identity, but there is no reason for this. Endwell has been recognized as a place even though it does not have separate government. Johnson City would continue to have a geographic entity within the Greater Binghamton area.

The history of the village, the formation of the study team, the details of the costs saved, and the coverage of all the departments are all there. If you are a resident of Johnson City, you owe it to yourself to study this plan. Those who do not have access to a computer can find copies at Your Home Public Library in Johnson City and the George F. Johnson Memorial Library in Endicott. On September 22, Bill Klish, Chair of the JC Dissolution team, will explain the Study Plan and be available for questions at our program meeting at the Vestal Library at 7:00 pm.

Whether the plan is voted for or not is in the hands of the residents of Johnson City.

I believe the Johnson City Dissolution Study Team should be commended for the time and effort they put into this complicated and challenging task. I am particularly proud of our League members who are on the Study Team: Bill Klish, Chair, and Dick Paden, Member.
