## Voter Service

### New Voting Machines for this Year's Elections

For the Primary Election on September 15 and the General Election on November 3, voters in Erie County will be using the DS200 optical scanning machine that will read paper ballots. The DS200 machine was developed by Election Systems & Software, Incorporated in Nebraska. However, voters in the City of Buffalo will still be using the old lever machines. In Niagara County, voters will also use an optical scanning machine but a different one called the Sequoia/Dominion Image Cast.

Though the machines are new in New York State and Ohio, several counties in Florida used the DS200 in the 2008 General Election. Some problems encountered in Florida with the DS 200 have been corrected according to the company. While the lack of a paper trail and worries about electronic votes disappearing have been key concerns, Erie County Elections Commissioner Dennis E. Ward noted, "The paper ballot voters complete is a paper trail itself. The ballot drops into the box. The original is there; it will be preserved. If all else fails we can hand-count ballots. At the same time the ballot goes through the counter, the machine digitally images that ballot and stores it, so in addition to the computer tallies, each system will also have pictures of every ballot cast."

### General Election

- Oct. 9 - Last day to register for the General Election - Registrations that are mailed must be postmarked by this date and received by the Board of Elections by October 14. Exceptions: if you have been honorably discharged from the military or have become a naturalized citizen after October 9, you must register in person at the Board of Elections by October 23.
- Oct. 14 - Last day to notify Board of Elections of change of address
- Oct. 27 - Last day to postmark application or letter of application for Absentee Ballot for the General Election
- Nov. 2 - Last day to apply in person for Absentee Ballot for General Election
- Nov. 2 - Last day to postmark Absentee Ballot It must be received by the Board of Elections no later than November 10.
- Nov. 3 - Last day to deliver Absentee Ballot in person to your Board of Elections
- **General Election Day - Tuesday, November 3, 2009**  
Polls open at 6 a.m. and close at 9:00 p.m. in both Erie and Niagara Counties.

## Media Event for West Valley Cleanup

Several members of the League of Women Voters of Buffalo/Niagara joined environmentalists carrying mops, brooms and buckets to demonstrate on September first in front of the offices of the New York State Energy Research and Development Authority (NYSERDA) in Buffalo. NYSERDA officials represent New York State as site managers of the West Valley nuclear waste site, along with officials of the U.S. Department of Energy (DOE). The DOE is primarily responsible for implementation of the 200-acre West Valley Demonstration Project (WVDP) at the site about 35 miles south of Buffalo. They manage 90% of the funding to cover their expenditures that include hiring contractors to work on the project and cleanup. Because New York State owns the full 3340-acre site, NYS citizens have a huge stake in the extent of future cleanup of the site. **DOE's preferred alternative** in the draft environmental impact statement (DEIS) issued last December **is a partial cleanup** involving about 1.2% of the radioactivity on site, **with a delay of up to thirty years for further decisions** regarding cleanup. The site has been problematic from its beginning as a commercial attempt to recycle nuclear fuel rods that ended in the early Seventies. Despite the successful vitrification of high-level liquid waste as part of the Demonstration Project Act of 1980, DOE preference for further delay in decision-making is unacceptable as an alternative.

League members have been following this issue for decades and it is not going to go away soon. The latest and most exciting news is that Betsey Swan, president of the League of Women Voters of New York State, on behalf of all of us, has sent comments to the DOE regarding the new Draft (DEIS). She also sent a letter to U.S. representatives from Western New York- Higgins, Massa and Slaughter, as well as to Senators Schumer and Gillibrand. State Senate Chair Silver, Assembly Speaker Smith and Governor Paterson request assistance to advocate for a full cleanup of the site. The League also issued a press release in that regard (available on line at [www.LWVNY.org](http://www.LWVNY.org)) that was read during the media event.

Attending the event were Loretta and Chuck Peszynski, Amy Witryol, Ann Ingleman, Ellen Moomaw, Joan Herold, Ellie Becher and Lee Lambert, who answered questions about the site. TV Channel 7 covered the demonstration, and shots of two speakers from the League and the Seneca Nation were included in their newscast that evening. On Wednesday, September 2, 2009, *The Buffalo News* article, "Coalition urges complete West Valley cleanup", <http://www.buffalonews.com/cityregion/otherwny/story/782237.html> reported about other speakers.

It was gratifying that there were so many League members in attendance. What better way to spend one of the few sunny days we had in Buffalo this summer than demonstrating for the League? Talk about dedication!
