## Exploring the Greening of Daemen College

On May 15, 2010, LWVB/N members and guests will have the opportunity to hear a presentation by Dr. Brenda Young, Natural Sciences Chair at Daemen College. Last June she was awarded national LEED Professional Accreditation by the Green Building Certification Institute that recognizes excellence in green building performance and practice. LEED certification is awarded for Leadership in Environmental Engineering and Design.



Dr. Young will describe the process that led her and Professor of Design, Kevin Kegler, along with their students to create a campus **Ecotrail**. After her presentation, attendees will have the opportunity to walk the **Ecotrail**. At the starting end is a green roof - a small shed whose roof is dotted with succulents. The original purpose of green roofs is to insulate buildings and to protect the roof itself. There is a Rain Garden on the trail. Spider Warts and Sedges are planted to help absorb water from surrounding lawns and parking lots. A large drainage pipe on the property was not moved away, but serves as a seating bench. Heavy stone parking barriers now serve as stepping-stones along the trail and as crossing stones in a small brook on the trail.

After the **Ecotrail** tour, interested members and guests may tour the new Information and Research Commons Building on Campus. It is designed to conserve energy, water and other resources, maximize the use of recycled materials and minimize the use of toxic materials. It is one of the first freestanding "green" buildings on a WNY Campus.

## The Census: Reallocating Political Power in America

Beginning in May census enumerators will fan out across the country to count every person in America. Government officials will cheer them on as will countless civic, racial, ethnic, and cultural organizations – and for good reason. The stakes are high. The census numbers will be the basis for determining financial benefits (\$400 billion in 2010) at every level of government for everything from roads and bridges, to education, health care and social services.

**But even more important, the population figures will determine how seats in the House of Representatives and other legislative bodies are reapportioned.** The Constitution requires that all people living in the country be counted every decade to determine the number of seats each state will have in the House of Representatives. The first House had only 33 members; each state had one seat and the remaining seats were divided according to population. After the census in 1790 the number of seats jumped to 66. As the population grew after each census so did the number of House seats until 1910 when the number reached 435 and was then capped. As a result, the average number of constituents per representative increased from 30,000 in 1790 (total population 3.9 million) to 670,000 in 2000 (total population 291.4 million).

Originally each state was free to determine the boundaries and the size of its congressional and state legislative districts. Citizens argued endlessly about how redistricting should be accomplished and over perennial problems such as population inequality. (In 1930 New York's smallest district contained only 90,700 voters, but the largest had 776,400 voters.) All this changed dramatically during the 1960's with a series of stunning U.S. Supreme Court decisions on apportionment. In 1962 the Court declared the "one person, one vote" principle, which required states to draw Congressional districts based on equal population. It later extended this principle to include all governmental legislative districts. In 1965 it forbid political gerrymandering to dilute the votes of black and then Hispanic minority populations.

With apportionment clearly a federal issue, the LWVUS initiated a national study and in 1966 announced member agreement in support of the Supreme Court's "one person, one vote" principle, that government legislative bodies be apportioned substantially on population.

The New York State LWV had reached similar consensus a few years earlier but included additional standards that would require legislative districts to be: geographically compact; contiguous; respectful of existing political boundaries and minority communities; and competitive. The League has been highly critical of the present system in which sitting legislators draw legislative districts that protect incumbents and their political parties. The League has long supported an independent non-partisan redistricting commission that would draw districts in a fair and impartial manner and a redistricting process that provides for public participation and comment. The commission's redistricting plan would be submitted to the legislature for approval.

We are meeting our state legislators this spring. We will ask them to firmly commit to redistricting reform that includes an independent redistricting commission.
