FIX ALBANY NOW – Steps To A New and Better State Government

- **Redistricting** – Create an independent redistricting commission to draft the New York State Legislative and Congressional political boundaries for the 2012 elections.
- **Campaign Finance Reform**– Support lower contribution limits and increased disclosure. In particular support stronger and effective campaign finance enforcement with increased civil and criminal penalties for violations.
- **Ethics Reform**– Put in place a new independent ethics over-sight agency and rougher enforcement. Make the legislature more open and accountable through continued rules reform.
- **Election Reform**–Improve election processes to extend, encourage and protect voting, including Election Day registration, better ballot design, improved polling place management/poll worker training, and measures to ensure the integrity of all ballots.

Remember: Local Leagues can still take action in other areas on which LWVNYS has positions. (Health Care, the Judiciary, Natural Resources, State Finances and Social Policy including Women's Issues.

The League of Women Voters of New York State Convention will be held May 20-22, 2011
at the Desmond Hotel in Albany, New York.

The state board invites members to make suggestions for workshops at the convention.

International Relations, A Continuing League Issue

The Erie County League of Women Voters in the late 1920s and early 1930s was an active participant in discussions on world peace.

Conferences on the topic were held in Washington, D.C. organized by leading women's groups. The LWV was represented at one conference by Mrs. Park Lewis, chair of the Erie County League Committee on International Relations. The National League was represented by Belle Sherwin, League President.

Locally the Amherst Branch of the League at a monthly meeting was addressed by Mrs. Howard Stimm on the preliminary movements for peace and Mrs. William Ford, who spoke about the peace movement efforts that paved the way for the London Naval Conference. Mrs. H.G. Lauman opened a discussion on the London Naval Conference.

In 1932 the Courier Express covered what it termed "an amazing assemblage against war" organized by the Erie County League in conjunction with all Western New York women's organizations. A mass meeting held at the Hotel Statler at which Philip C. Nash, director of the League of Nations Association, addressed 1200 Western New York women.

This interest in world affairs and peace movements is carried on today within the league by the Great Decisions discussion group, meetings at the United Nations each fall and participation of League members in local groups working for an end to war.

Smart Growth Bill Passed

The Local Government Committee would like to report some important progress at the state level on one of our key issues. We have been working on sprawl, regional planning, and smart growth for more than ten years now. We think that our Education Campaign on Urban Sprawl <http://lwvbn.org/lwvbnactivities/sprawl/sprawl.html> has been an important influence in educating citizens about the costs of sprawl and the importance of "smart growth."

Our committee spearheaded the development of a state position on sprawl in 1999. In 2009, under that position, The League of Women Voters of New York State joined the coalition called Empire State Future, "a coming together of many civic improvement organizations, planning groups, and individuals interested in advancing the principles of 'smart growth' and turning them into reality in cities, towns and villages all across the Empire State." As part of Empire State Future, the League has been effective in lobbying for state legislation to address the costs of sprawl.

Locally, State Assembly member Sam Hoyt has long understood the costs of sprawl and the need to prevent state infrastructure spending from promoting sprawl. For years, he has submitted smart growth bills to the state legislature, where they were received with little enthusiasm or understanding. Finally, this year, with strong lobbying support from Empire State Future, Hoyt and his colleagues managed to pass the Smart Growth Public Infrastructure Policy Act. It guides the State in making more sustainable and strategic infrastructure investments. This legislation requires State agencies to create Smart Growth Advisory Committees that would evaluate public infrastructure investments based on the Smart Growth criteria and will require such investments to meet the criteria to the extent practicable. The Governor signed the bill at the end of August and came to Buffalo in October to highlight its passage. We are proud of the role the League has played in the passage of this bill.

2010 Election Survey: Machines Perform But Privacy Suffers

The League of Women Voters of New York State (League) released the results of an online survey of voters' experiences using the new paper ballot optical scanning system that was implemented statewide for the 2010 election cycle on December 16, 2011.

The online survey of 1,072 respondents, from 47 counties including all 5 counties of NYC, showed that the voting machines indeed did perform well; however, the respondents did make note of several inadequacies that the League feels must be addressed to ensure that voters are guaranteed a secure and private franchise. The League's recommendations for immediate action are listed below; the state Board of Elections should move to implement these recommendations before the next election cycle.

• Increased Voter Education on the Voting Process

The State Board of Elections must provide standard template materials which county boards of elections can tailor for their specific needs. Remaining HAVA funds should be used for this purpose.

• Increased Training for All Elections Personnel

The survey showed an immediate need for better-trained election personnel. Legislation has passed permitting split shifts for election inspectors and recruitment of younger poll workers. These new laws need to be implemented.

• Revision of the Paper Ballot for Maximum Usability by Voters

There is an immediate need for improving the design of the ballot. Legislation to address the full-face ballot should be a legislative priority and should be introduced early in the 2011 Legislative Session.

• Privacy Issues

Over 20 percent said they did not have sufficient privacy in marking the ballot, scanning the ballot, or were not given a privacy sleeve or instructed how to use it. Poll workers need to be trained that any viewing of the markings on a completed ballot is a violation of the voter's privacy.

As noted by League Elections Specialist, Aimee Allaud, "Improving ballot design, providing better trained poll workers and ensuring privacy in voting are fundamental to our voter electoral system. We must take immediate steps to resolve these problems."

"The League's Voter Survey shows that we need to do much, much more if we're to take full advantage of the State's new voting systems. In particular, the design of New York's ballot must be completely overhauled in order to be fully usable by voters." said Bo Lipari, the League's Technology Director.
